## PROTECTING Our ENVIRONMENT

State and Federal Communications is committed to doing its part to protect the environment. We focus on four areas: 1) single-use packaging, 2) paper and cardboard, 3) electronic waste, and 4) fluorescent bulbs. The waste generated at the office prompted our commitment to work with the city of Akron's single-stream recycling program for downtown businesses. Single-use containers, such as plastic bottles, aluminum cans, and product boxes can now be placed in proper recycling bins rather than sent to landfills. In 2014, State and Federal Communications began using a reverse osmosis water dispensing system. In 2018, the company supplied each employee with a S'well® bottle to reduce the need for single-use containers. State and Federal Communications recycles paper and cardboard waste. SecurShred (Weaver Industries, Akron) shreds and recycles all our business paper. The city of Akron program collects flattened cardboard for processing at its local facility, which is managed by Greenstar Recycling of Houston, Texas. Both electronic waste and fluorescent bulbs are toxic when buried in landfills. Our policy is to upgrade all failed fluorescent bulbs or fixtures to LED. All retired fluorescent bulbs continue to be processed by Veolia North America. All computers, monitors, cables, batteries, and small electronic items taken out of service annually are sent to eWaste of Hudson, Ohio, for proper handling and disposal.2

¹Akron's Curbisde Recycling program does not provide individual results. Instead, community results are reported to the state EPA in the aggregate by Summit ReWorks. ²Copier/printer cartridge (toner and waste) recycling efforts have always been the preferred method of handling this waste by-product, but the effort was not tracked. Beginning in 2019, this effort is being recorded to better gauge impact.

#### **Cans for Corridors**

In September 2019, State and Federal Communications began to partner with the Akron Zoo in their Cans for Corridors program. By bringing aluminum cans to their collection center, the Akron Zoo sends the money collected from recycling to the Durrell Wildlife Conservation Trust. This organization works with Instituto De Pesquisas Ecologicas in Brazil to plant trees, reestablishing vital tree corridors in the suffering Brazilian rainforest. By discarding our used aluminum cans, we are now planting trees in Brazil! In 2019, we collected **1100 cans** and planted **21 trees.**

## STRENGTHENING Our COMMUNITIES

Smart partnerships are critical to the success of our CSR strategy. State and Federal Communications works with area organizations to provide significant benefit to the community far beyond what our individual contributions could do.

This company partners with the United Way of Summit County because of its commitment to community impact. We have held United Way campaigns for the last 20 years. State and Federal Communications matches every dollar donated by its employees. We had 100% employee participation in the 2019 campaign. The company received the United Way of Summit County's Firestone Award for highest per employee gift in a company with fewer than 100 employees. We

raised \$28,672, plus the company's matching funds and our Donut and Cider Sale's total of \$812, bringing us to a grand total of \$58,156! The pledge was a six percent increase over the previous year. The average staff pledge was \$774.91.

Additionally, our Spring-Cleaning Drive collected 124 articles of business-appropriate clothing for the Akron Urban League's Walk-In Closet program. We collected 1,378 school supplies to fill 40 backpacks for the United Way Stuff the Bus Program. We collected 64 items of winter clothing, benefitting the outreach of the Akron Snow Angels, who offer help to the most vulnerable in our community during winter months.



#### **Harvest for Hunger Campaign**

State and Federal Communications held its first official Harvest for Hunger Campaign for the Akron-Canton Regional Foodbank in 2019. Employees raised \$334 and President and CEO Elizabeth Bartz offered to match our contribution. The company's donation of \$668 means 2,672 meals were provided to the hungry in our community. On May 17, State and Federal Communications was recognized by the Akron-Canton Regional Foodbank for its Bronze level campaign.

State and Federal Communications is an organization that values community. Our employees volunteered in nonprofit settings,

served on nonprofit boards, and attended community events. **We show up!** Hands-on community experience has been important for the staff's

leadership, team building skills, and familiarity with the needs of Northeast Ohio.

Our Charitable Service Program: As a benefit of donating 1% of their salary to the United Way campaign, employees of State and Federal Communications received 30 hours of charitable service. The employees can use those hours at the nonprofit of their choice. The staff have volunteered at The Akron Canton Regional Foodbank, the Akron Urban League, The Akron Public Schools, and Project Grad Akron, among other organizations. Our staff used 94 hours of charitable service, a 19% increase over the previous year.

Hunger is a national crisis, which we take seriously. In 2019, 10 employees worked 134 hours helping with food distribution at the Annunciation Church of Akron's Good

Samaritans program. (This is a 270% increase over the previous year.) Three staff members volunteered at the SOS Callahan Community Kitchen as a kickoff for the Public Affairs Council Advocacy Conference in Key West, FL. This community kitchen does food outreach for children and the elderly who are experiencing food insecurity.

United Way Community Engagement: Twelve employees participated in the United Way Day of Action on June 21 at the Akron Rotary Camp. We sorted hundreds of school supplies for the United Way Stuff the Bus Sort-a-Thon on August 21 and helped deliver them. Elizabeth Bartz and two staff members read to elementary students in United Way's Read to Me Day on November 7.

#### **PROJECT PATRIOT**

The Annunciation Greek Orthodox Church of Akron's chapter of Philoptochos raised money to support the Harry Donovan, Jr. Valor Home of Summit County.

The Harry Donovan, Jr. Valor Home is a transitional residence for homeless male veterans in Akron, OH. The Valor Home houses 30 male veterans for 6 to 9 months and assists them in achieving independence and securing permanent housing and jobs. Veterans participate in art, music, and life skills therapies; self-improvement activities; exercises in self-sufficiency; and self-advocacy training.

The Akron Philoptochos raised funds through a variety of projects throughout the year. They replaced furniture in the living areas; purchased bookcases, computer tables, and a commercial-grade food processor; installed stainless steel shelving in the pantry; and raised money for other items on the Valor Home's wish list.

State and Federal Communications donated \$1,195 in 2019 toward this noble cause.

#### **EDUCATION**

State and Federal Communications proudly supports education in our community in several ways. The company has offered 63 paid internships to college students in Northeast Ohio since 2002. In 2019, nine interns participated in the program.

We work hard to ensure the internship experience gives value to the interns and to the organization. The interns work in various departments of the company and they work with nonprofit organizations making a difference in the community. They are afforded excellent networking and professional development opportunities in Leadership Akron's Edge program.
